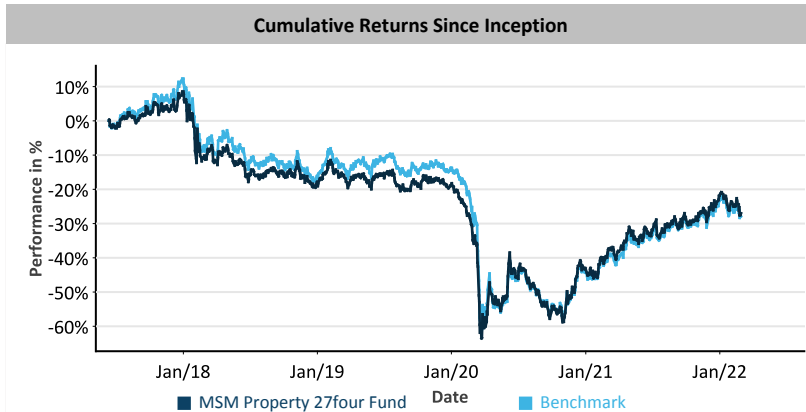
MSM PROPERTY 27four FUND B2

Investment summary: The fund invests in listed property equities listed on the JSE. Returns are likely to be volatile, especially over short- and medium-term periods. Suitable for those investors who seek exposure to JSE-listed property equities to provide long-term capital growth as well as a steady income stream. Typically have medium to long term investment horizon i.e. 1 year and more.

Investment Objective:

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, REITS, and cash.

Monthly Commentary

With US Inflation at 7.5% above expectations, markets factored in several interest rate hikes by the Fed. Adding to inflation was the surge in commodity prices as a conflict between Russia and Ukraine ensued, seeing global markets dive as sanctions were placed on Russia by the West whilst other BRIC countries took a neutral stance. South Africa's fiscal budget was well received as R182bn was added onto the fiscus due to commodity companies. Business confidence was better with car purchases also improved. The listed property sector took a hit due to the geopolitical events with benchmark ending down -2.75%.

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. The TER can be based on the management fee (including VAT) of 0.40% and projected audit fees, trustee fees, custody fees and other administration costs for the next 12 months. TCs can be based on costs incurred to date, annualised for the year, including STT and brokerage fees, VAT inclusive.

Risk Guidance

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.
