Suitable for those investors who seek exposure to JSE-listed property equities to provide long-term capital growth as well as a steady income stream. Typically have medium to long term investment horizon i.e. 1 year and more.

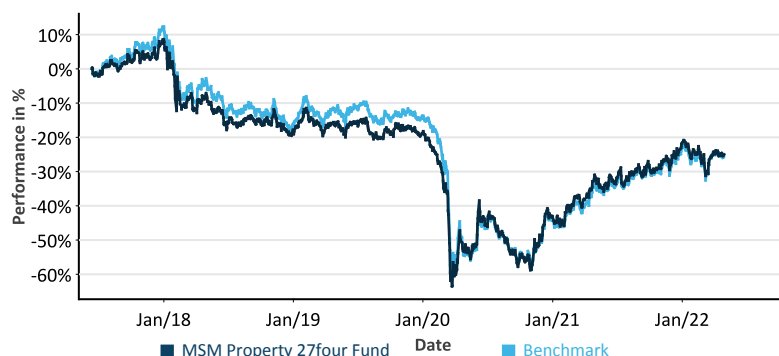
Investment Objective:

Monthly Commentary

The Ukraine/Russia war continued as global markets lost 8%, driven by the Federal Reserve increasing rates by 50bps. Market participants priced a recession for 2023 as U.S GDP contracted by -1.4% for the first quarter and the Nasdaq continued its bear market performance. The Eurozone economy expanded by 0.2% but inflation concerns exacerbated by the war pushed markets down whilst China maintained its zero Covid policy, destroying the economy for the month. South Africa was hit by widespread floods as 431 lives were lost. The Rand weakened by 7% as we outperformed at -0.88% vs the benchmark at -1.46%.

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. The TER can be based on the management fee (including VAT) of 0.40% and projected audit fees, trustee fees, custody fees and other administration costs for the next 12 months. TCs can be based on costs incurred to date, annualised for the year, including STT and brokerage fees, VAT inclusive.

Risk Guidance

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.
