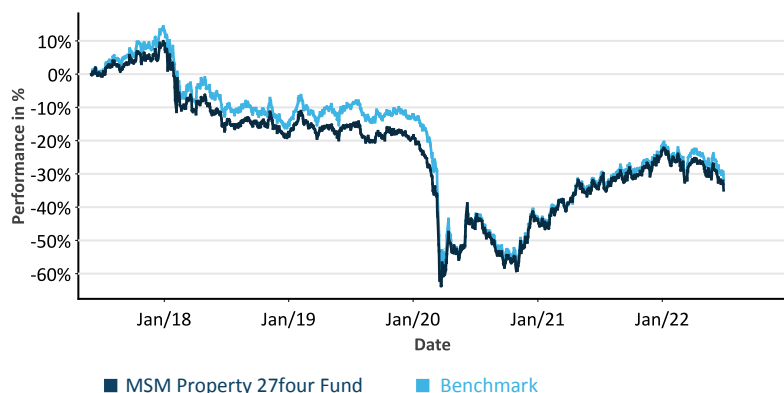

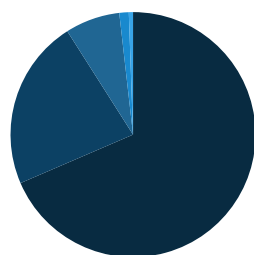

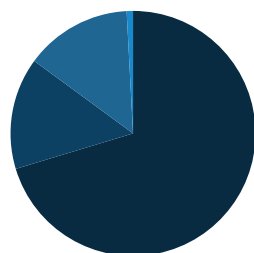

Commentary

The jobs data released beat expectations with unemployment sitting at 3.6%, giving confidence that it can weather a recession. Inflation came in at 8.6% for the US, triggering a sell-off, with S&P500 down -21% half year and Nasdaq -30%. The Chinese government continued with their move away from zero Covid policy, increased their pledge for boosting the economy and started decreasing regulation on the technology sector, ending the half year only down -0.60%. Our listed portfolio was down -10.72% due to the volatility as the South African economy printed 1.9% GDP beating estimates. The portfolio is meeting the objectives. The portfolio has delivered a negative return since inception, but has outperformed the benchmark, especially in 3 years.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
