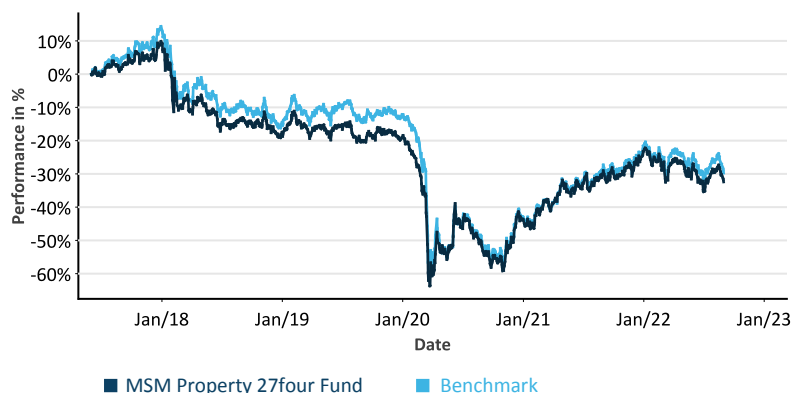

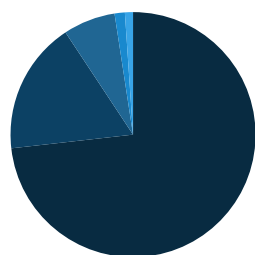

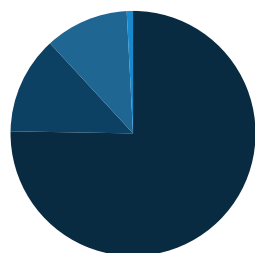

Commentary

The month of August saw global markets sell off as the Fed stayed the course on raising interest rates to stem inflation. The UK saw consumer inflation at a 40 year high (10.1%) with the BOE expecting it to top 13% by October. Continental Europe scrambled to secure energy sources for the upcoming winter as the Ukraine/Russia war raged on. China continued its Zero-Covid policy for certain cities. South Africa saw loadshedding decrease as the earnings season produced good results for the JSE. We outperformed the index by 1.44% at -4.51% vs -5.95% by the ALPI benchmark.

Glossary summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
