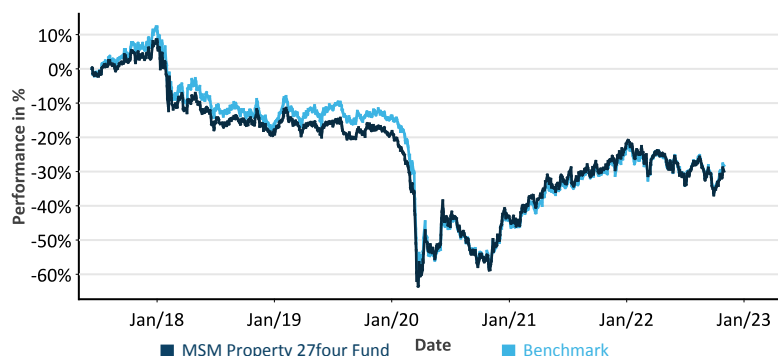
Investment Objective:

Commentary

October witnessed the Fed continue with its interest rate hikes yet the markets took the statements to be dovish, sighting the approach to ending the tightening cycle of central banks. The UK settled down with the election of Rishi Sunak and ripping up of tax-cutting budget whilst the Russian-Ukrainian war continued and the ECB increased rates by 75 basis points. China reaffirmed its zero-Covid policy and Xi Jinping got a third term. South Africa widened its trade surplus to R19.7 billion and saw SA employment up by 0.7% y/y. The portfolio was up by 9.62%, riding the optimism in the markets.

During the phase in period TERs do not include information gathered over a full year. Transaction Costs (TC) is the percentage of the value of the Fund incurred as costs relating to the buying and selling of the Fund's underlying assets. Transaction costs are a necessary cost in administering the Fund and impacts Fund returns. It should not be considered in isolation as returns may be impacted by many other factors over time including market returns, the type of Fund, investment decisions of the investment manager and the TER. The TER can be based on the management fee (including VAT) of 0.40% and projected audit fees, trustee fees, custody fees and other administration costs for the next 12 months. TCs can be based on costs incurred to date, annualised for the year, including STT and brokerage fees, VAT inclusive.

Risk Guidance
