Musi Skosana holds a MSc from University of Witwatersrand and a Postgraduate Diploma in Management from Wits Business School.



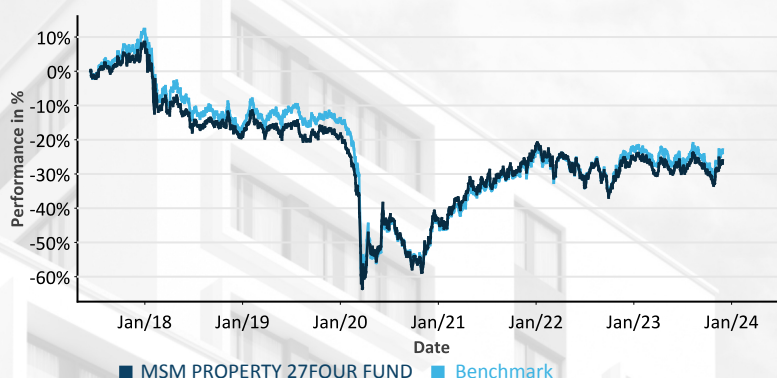

Cumulative Returns Since Inception



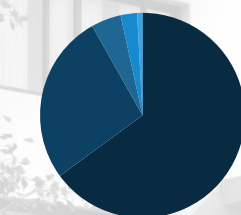

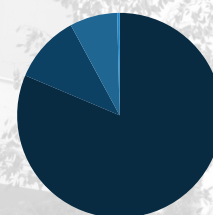

Commentary

The risk-off sentiment witnessed during the month of October saw S&P 500 down -2.10% exacerbated by the conflict in the Middle East along with the market factoring rates to be higher, for longer by the Federal Reserve. The Eurozone also followed the bad performance whilst the ECB kept rates on hold. Asia followed suit with concerns regarding the real estate sector in China still being a drag on the economy. Even with the Springboks winning, business sentiment was weak in South Africa along with the Rand weakening to 19.50 to the Dollar, dragging listed property down by -2.98%.

Glossary Summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
