Musi Skosana holds a MSc from University of Witwatersrand and a Postgraduate Diploma in Management from Wits Business School.



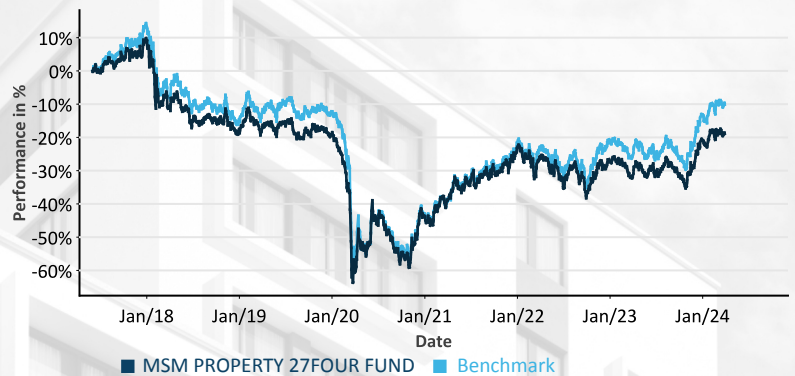

## Cumulative Returns Since Inception



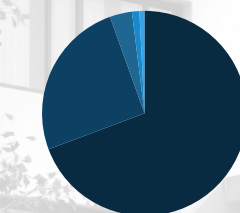

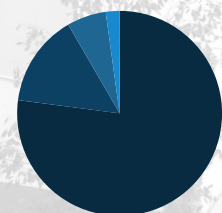

## Commentary

The S&P500 Index rallied up 3.22% for March, closing out a strong quarter (10.56%) buoyed by the magnificent seven (artificial intelligence theme) along with good US economic data. The ECB kept interest rates unchanged as European markets ended up 4% for March. Even with a sluggish property sector, China released good economic data as manufacturing numbers showed a recovery. South Africa released sluggish economic data but saw relief as South African GDP was reported to be 0.6% for 2023. The resources market made back some losses gaining 13.86%. Listed property was down by 0.5% as we beat the benchmark.

## Glossary Summary

**Volatility:** Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

## Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.
