Musi Skosana holds a MSc from University of Witwatersrand and a Postgraduate Diploma in Management from Wits Business School.



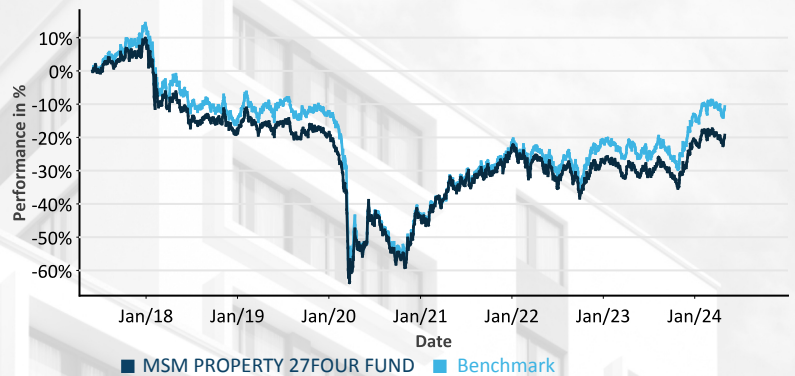

Cumulative Returns Since Inception



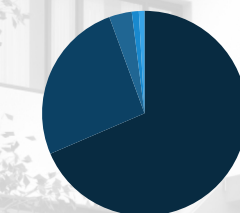

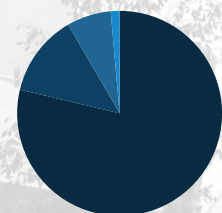

Commentary

Even though the Federal Reserve didn't have a meeting, markets began pricing in the reduced likelihood of the initiation of monetary easing. This was spurred on by CPI data which showed a marginal increase, which would be supported by the Mays' figures. European markets followed the US but were more optimistic on the ECB cutting rates due to economic data. China's economy showed more resilience than expected due to PMI data translating into a stronger performance. South African markets began trading flat as a response to the upcoming elections. We outperformed the index at -0.49%.

Glossary Summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
