Musi Skosana holds a MSc from University of Witwatersrand and a Postgraduate Diploma in Management from Wits Business School.



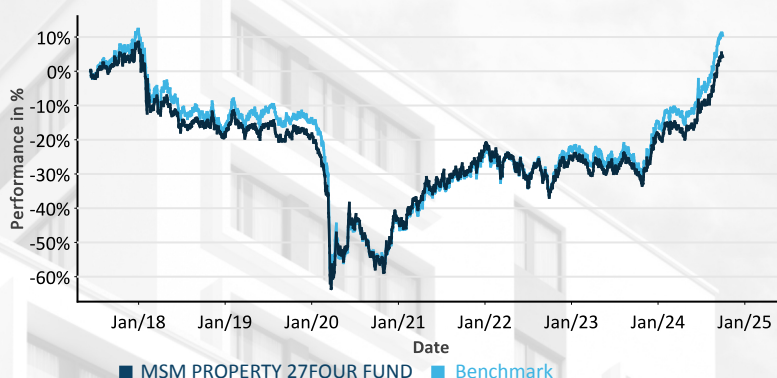

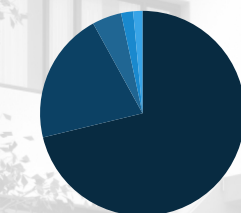

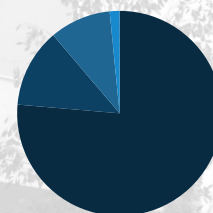

## Commentary

In September, developed market equities (MSCI World Index +1.9% MoM) benefited from the US Federal Reserve's 0.5% rate cut, while emerging markets outperformed, led by Chinese stocks (MSCI EM +6.7% MoM) on larger-than-expected stimulus measures. Locally, the FTSE/JSE Capped SWIX Index rose 4% MoM, with mining and property counters performing well due to stronger industrial metal prices and improving sentiment. The rand strengthened 3.2% MoM as global monetary easing boosted confidence in South Africa's economic outlook. The JSE All Property Index gained 5.16% MoM, supported by easing inflation (headline 4.4% YoY) and the SARB's 25 bps rate cut.

## Glossary Summary

**Volatility:** Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

## Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.
