Musi Skosana holds a MSc from University of Witwatersrand and a Postgraduate Diploma in Management from Wits Business School.



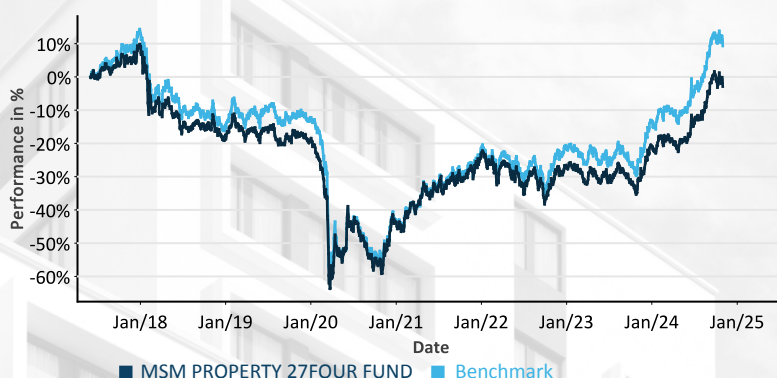

## Cumulative Returns Since Inception



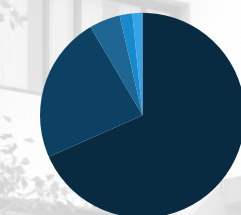

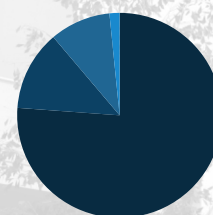

## Commentary

In October, global markets faced headwinds, with developed market equities (MSCI World Index -2.0%) and emerging markets (MSCI EM -4.3%) both declining amid rising US bond yields and conservative corporate guidance. South African equities mirrored this trend (FTSE/JSE ALL SHARE down 1.3%), with the JSE All Property Index, a strong performer earlier in the year, also affected, dropping by 2.7% MoM. Finance Minister Enoch Godongwana's Medium-Term Budget Policy Statement underscored fiscal discipline, and stable inflation data aligned with expectations, supporting prospects for future rate cuts. The SA 10-year bond yield ended the month at 10.6%.

## Glossary Summary

**Volatility:** Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

**Max Drawdown:** The maximum peak to trough loss suffered by the Fund since inception.

**Sharpe Ratio:** The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

**Annualised performance:** Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

**Highest & Lowest return:** The highest and lowest returns for any 1 year over the period since inception have been shown.

**NAV:** The net asset value represents the assets of a Fund less its liabilities.

## Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.
