Musi Skosana holds a MSc from University of Witwatersrand and a Postgraduate Diploma in Management from Wits Business School.



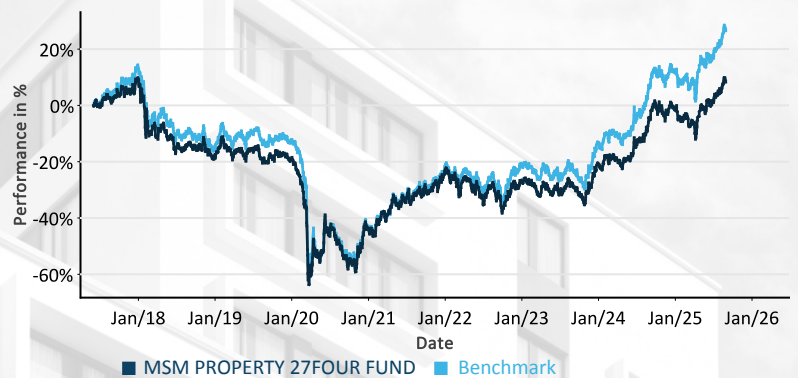

Cumulative Returns Since Inception



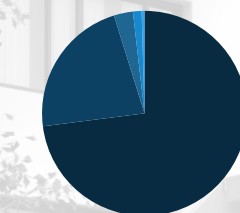

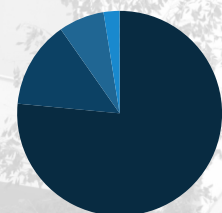

Commentary

Global markets in August 2025 delivered mixed but generally positive performances. U.S. equities gained, with the S&P 500 up +1.9% and the Dow Jones advancing +3.2%, supported by resilient consumer spending. European markets were softer, with the MSCI Europe ex-UK up only +1.2%, while the UK's FTSE All-Share added +0.9% amid sluggish growth. Emerging markets rose +1.5%, and Chinese stimulus underpinned modest recovery. Global developed equities gained +2.6%. Commodities softened, with oil and gold drifting lower. Property and REITs rebounded strongly: the global FTSE EPRA Nareit index rose +3.7%, while South African REITs advanced +2.4%, reflecting improved sentiment in listed property.

Glossary Summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
