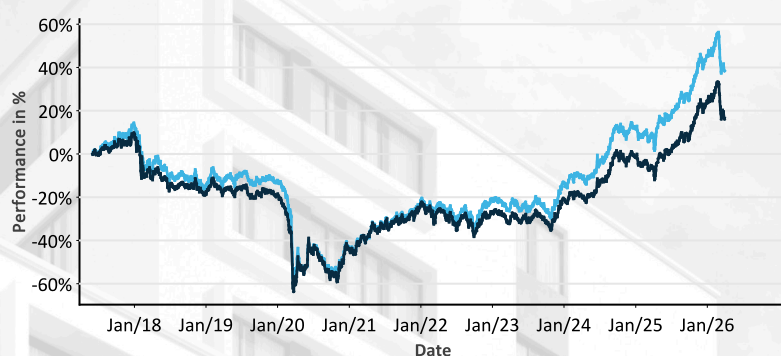

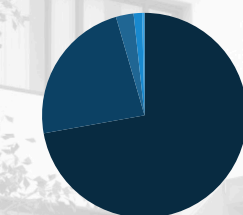

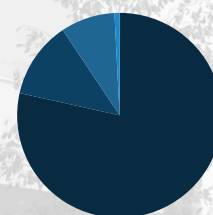

Commentary

South African markets faced sharp riskoff conditions in March as geopolitical tensions, rising oil prices and a weaker rand weighed on local assets. Equities, bonds and interestrate-sensitive sectors all retreated, with the FTSE/JSE All Share Index falling 10.5% for the month. The SA listed property sector underperformed, declining a significant 12.3% in March as REITs gave back earlier yeartodate gains amid higher global yields and inflation concerns. Despite the selloff, sector fundamentals remain resilient, with improving balance sheets and 12month distribution growth of 9.4%, suggesting the pullback reflects valuation derisking rather than deteriorating operating conditions.

Glossary Summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
