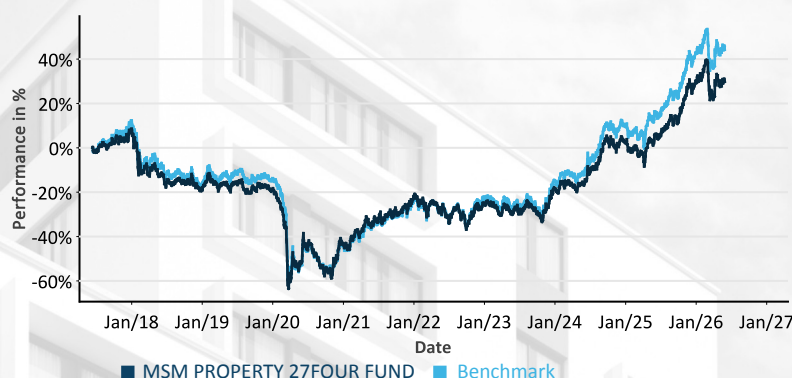

Cumulative Returns Since Inception



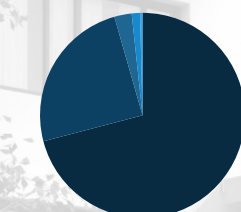

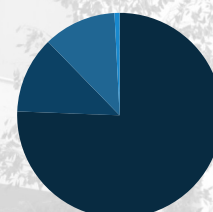

Commentary

South African financial markets delivered a mixed performance in May 2026 as investors balanced improving domestic fundamentals against ongoing global uncertainty. The FTSE/JSE All Share Index remained resilient, supported by financials and industrials, while the Rand strengthened intermittently on improved risk sentiment and softer oil prices. South African listed property stocks traded firmer during the month, extending the sector's recovery from the first quarter. The FTSE/JSE All Property Index gained modestly over May, supported by attractive income yields, improving distribution growth expectations and renewed institutional demand for REITs. Investor sentiment toward quality property counters remained constructive.

Glossary Summary

Volatility: Volatility refers to the amount of uncertainty or risk related to the size of changes in a security's value. A higher volatility means that a security's value can potentially be spread out over a larger range of values.

Max Drawdown: The maximum peak to trough loss suffered by the Fund since inception.

Sharpe Ratio: The Sharpe ratio is used to indicate the excess return the portfolio delivers over the risk-free rate per unit of risk adopted by the fund.

Annualised performance: Annualised performance shows longer term performance rescaled to a 1-year period. Annualised performance is the average return per year over the period. Actual annual figures are available to the investor on request.

Highest & Lowest return: The highest and lowest returns for any 1 year over the period since inception have been shown.

NAV: The net asset value represents the assets of a Fund less its liabilities.

Investment Objective

The fund is an actively managed fund that has a total return objective that is to grow income stream as well as capital growth. In order to achieve this investment objective the securities normally to be included in the portfolio will primarily consist of property shares, Real Estate Investment Trusts and cash.

Risk Guidance
